The education and experience requirements are: Bachelor's degree and 2 years experience. Master's degree or doctorate degree and 1 year experience. Degree major must be in a science curriculum. Associate membership is available to those individuals who do not possess the above education and/or experience (see below).

The following membership categories and additional requirements are established.

Regular - \$25 annual fee-Above education and experience and currently working as a forensic scientist.

Provisional - \$25 annual fee-Above education, currently working as a forensic scientist, but lacking necessary experience. No voting or office holding privileges. Provisional members may apply for regular membership upon reaching required level of experience.

Associate - \$25 annual fee-Open to persons not possessing requirements for regular membership. No voting or office holding privileges.

Student Affiliate - \$10 annual fee-College students majoring in the sciences. No voting or office holding privileges.

Organizational - \$100 annual fee-Companies/organizations providing services or products to forensic labs. No voting or office holding privileges.

Emeritus - No annual fee, age 55, retired. Requires 2/3 vote of a member's quorum.

Life - No annual fee, at least 10 years as an NJAFS Regular Member. Requires 2/3 vote of a member's quorum.

Make checks payable to NJAFS. Include a \$5.00 application fee, along with the applicable membership fee. The above information is general in nature. Membership types are determined by the NJAFS Executive Committee and the membership in accordance with the NJAFS By-Laws. NJAFS reserves the right of final approval, at its discretion, of any application for membership.
